

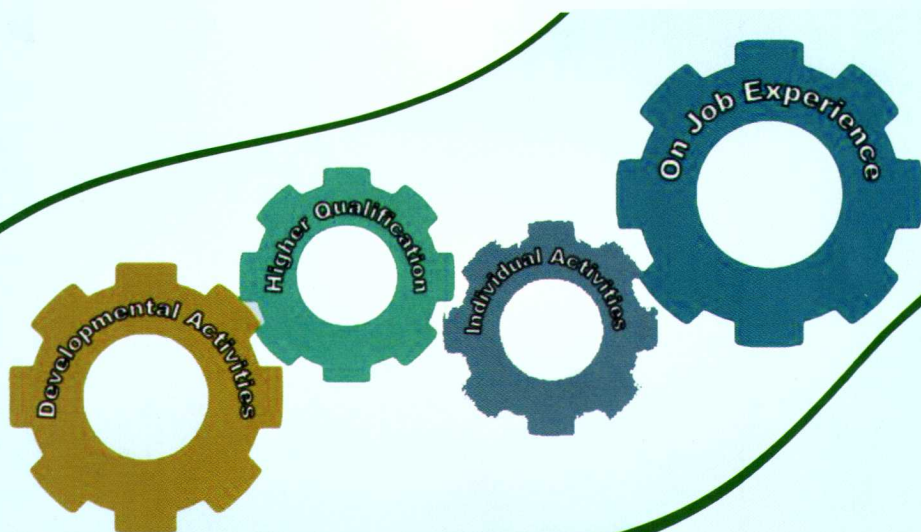

Pakistan Engineering Council (PEC) under PEC Act and CPD-Byelaws, is earnestly working for the professional growth and skill enhancement of ever growing engineering community. Under CPD framework, the engineers (both PEs and REs) are required to learn ingenious skills to be more effective in playing productive role towards nation building. With these objectives, CPD framework of PEC sets parameters under four dimensions including developmental activities (short courses, trainings, workshops, research publications, professional memberships, Member of any Technical Committee etc.), higher education, individual activities and on-job experience. This framework is for the ultimate benefits of engineers in their career development and renewal of registration as well as for elevation from registered engineer (RE) to Professional Engineer (PE) and also leading to International Professional Engineer (Int PE).

Under New Vision of CPD, specialized job-oriented and global certification courses are being introduced to enhance employability and on-job performance. PEC itself and through its registered Professional Engineering Bodies (List available on PEC website), regularly conducts short course, trainings and seminars to facilitate the engineers in fulfilling the CPD requirements. CPD Requirements and How to Earn CPD Points

The CPD requirements are as below for Registration Renewal of PEs and REs
For PEs (Professional Engineers):

For Life Members	For Yearly Subscribers
9 CPD Points (3 CPD Points per year)	3 CPD Points per year

For REs (Registered Engineers):

1st Year after Registration	1st Cycle of 3-years (2nd to 4th Year after Registration)	2nd Cycle of 3-years (5th to 7th Year after Registration)	3rd Cycle of 3-years (8th to 10th Year after Registration and onwards)
Grace Period	9 CPD Points (3 CPD Points per year)	12 CPD Points (4 CPD Points per year)	15 CPD Points (5 CPD Points per year)

How to Earn CPD Points

The REs and PEs can earn CPD points against activities as below with valid documentary evidence:
